## CONDITIONS OF ENROLLMENT

1. **CAMP FEES/DEPOSITS-** Camp fees are due and payable to CAMP COTTONTAIL by May 15<sup>th</sup> 2012. If deposit is paid by credit card you hereby authorize Camp Cottontail to charge balance to same credit card on May 15<sup>th</sup>, unless otherwise authorized. In accordance with accepted policy of the Western Association of Independent Camps, it is understood and agreed that no refund or reduction in fees is made for the cancellation of a camper, his/her late arrival or early departure for any reason including homesickness or should he/she be asked to leave due to misconduct. Should a camper become ill or injured during their stay at Camp Cottontail, it is our policy to refund one-half the unused fees or allow a full credit for future use. **DEPOSIT AND/OR FEES WILL BE REFUNDED IN FULL AND SESSIONS MAY BE CHANGED, PROVIDED NOTICE OF CANCELLATION OR CHANGE IS GIVEN BY EITHER PARTY PRIOR TO APRIL 1, 2012. THERE WILL BE NO REFUNDS AFTER THIS DATE.** Sessions may be added at current rates provided space is available. **Please** indicate first, second and third session choices. A waiting list will be started after all space has been reserved. Names will be added to the list in the order in which applications and deposits are received. If reservations cannot be confirmed, these deposits are refunded in full.

2. **CAMP STORE - Items** such as t-shirts, hats, postage, sundries and souvenirs may be purchased in the Camp Store. Water and Gatorade as well as various snacks will be available for purchase daily. We suggest a \$50 deposit per two – week session. Camp Store deposits by credit card only. Campers should NOT have any CASH with them while at camp. If campers bring spending money we will collect at beginning of session and keep locked up until needed.

3. **HEALTH** – I hereby give permission to physician, nurse or First Aid certified staff selected by Camp Cottontail to obtain and administer medical treatment or medication for my child as necessary. These medications may include but are not limited to the following or their generic equivalent: Calamine lotion, Betadine, milk of magnesia, Pepto Bismol, Tylenol, Neosporin Ointment, sunblock, Sucrets, sting ointment, Blixtex and Visine. I understand that Camp Cottontail will make all reasonable efforts to contact me should any emergency arise. To accommodate this effort, I will keep Camp Cottontail advised should I be away for any period of time during the camp session. I understand that I will receive a health form, and this it must be filled out by a physician and submitted to Camp Cottontail twenty (20) days prior to camper's arrival at camp.

4. **CABIN REQUESTS** – Campers are grouped by ages. Our normal groups are as follows: seven, eight and nine year olds, ten, eleven and twelve year olds, and teens. Please be aware when making requests that there should be no more than one year difference in the ages of the campers and if the campers are in two different groups the older child will be placed in the cabin with the younger group. Please limit requests to two per cabin. We will do our best to accommodate requests but we make no guarantee.

5. **GENERAL MATTERS -** I understand and acknowledge that certain camp activities (whether or not listed on website or in printed material) including but not limited to wakeboarding, kayaking, jet skiing, mini –bikes, rock climbing, ropes course, zip lines etc. have an increased risk of injury. The camper's family accident and medical insurance shall be the primary source of payment for any accident, injury or illness arising while attending camp.

I agree that Camp Cottontail is not responsible for articles of clothing or personal belongings lost or damaged by fire, theft, laundry, etc. I understand that Camp Cottontail does not recommend campers bring expensive clothing, radios , cameras, jewelry etc.

I agree that the camper and his/her parents and relatives will abide by the rules and regulations set by Camp Cottontail for the health, safety, and welfare of the camper.

It is understood and agreed by camper and parents that the use or possession by a camper of drugs, or drug paraphernalia , tobacco products, alcoholic beverages, any illegal controlled substances, or weapons are permitted and will be cause for immediate dismissal. Pets are also not allowed. There will be no refund of any part of fees for those dismissed.

I understand that Camp Cottontail encourages frequent letter writing but **NO PHONE CALLS** or visits will be allowed unless an emergency exists. In addition, **DO NOT SEND CELL PHONES** with your child to camp. They are not allowed and will be confiscated.

I agree that Camp Cottontail reserves the right to cancel, change or substitute programs or activities as listed in our brochures, videos, slides or website when necessary.

I consent to the use of any pictures or video of my child for advertising or promotion.
